- Adheres to the driving schedule assigned by the scheduler, transporting clients safely and courteously to and from their destinations.
- \* Performs thorough vehicle safety inspection prior to departure, noting and immediately reporting any concerns or deficiencies to the Coordinator or designate.
- \* Maintains regular communication with scheduling staff throughout each shift, reporting problems, concerns or updates.
- \* Completes all required documentation accurately and promptly.
- \* Complies with all Health and Safety Regulations, Ontario Traffic Safety Act, MTO Regulations and Centre policies and procedures.
- \* Role can be physical demanding ensuring client safety and care.

### What Do you Bring to the Position?

- Aptitude for working with older adults and persons with disabilities, professional, kind, non-judgemental, accountable, solution focused with strong communication and client care skills.
- Computer literacy and smartphone experience needed.
- Able to work flexible hours, possible weekends, travel to London, St. Thomas, Chatham and surrounding areas in all weather conditions. Typically, although not guaranteed, schedule is a week on, week off. Approximately 20 hours bi-weekly and possible call-in shifts.
- Possess a G license and good driving record required.
- Experience operating a wheelchair lift and a minimum of 3 years' driving commercial fleet or buses *preferred*.
- Current driver's abstract, verification of full Covid-19 vaccination status or verified medical exemption and vulnerable sector police check *required*.
